The Foglia YMCA will be responsible for coordinating the mailing. Andrew Seagren has engaged the music by Bopology for the July 26 summer concert. The Commission hopes to get a commitment from the Steel Drum Band for the June 14 summer concert. The Commission also noted that the deadline for spring/summer events mailing was earlier due to the March 23 date of Easter this year.
